**Summary Annual Report for
I.U.O.E. LOCAL #132 APPRENTICESHIP FUND**

This is a summary of the annual report for I.U.O.E. Local #132 Apprenticeship Fund, EIN 55-0523152, Plan Number 501, for the period April 1, 2008 to March 31, 2009. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$3,940,957 as of March 31, 2009, compared to \$3,289,155 as of April 1, 2008. During the plan year the plan experienced a change in its net assets of \$651,802. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,980,989 which included employer contributions of \$1,750,908, employee contributions of \$0, gain/loss of \$-2,271 from the sale of assets, and earnings from investments of \$-149,349.

Total plan expenses were \$1,329,187. These expenses included \$1,329,187 in administrative expenses and \$0 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
