This is a summary of the annual report for the IUOE LOCAL NO. 132 HEALTH & WELFARE FUND, (Employer Identification No. 55-0455491, Plan No. 501) for the period July 1, 2018 to June 30, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$119,363,518 as of June 30, 2019 compared to \$94,697,821 as of July 1, 2018. During the plan year the plan experienced an increase in its net assets of \$24,665,697. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$64,015,225. This income included employer contributions of \$53,563,116, employee contributions of \$1,702,937, realized losses of \$174,901 from the sale of assets and earnings from investments of \$8,903,347. Plan expenses were \$39,349,528. These expenses included \$2,823,341 in administrative expenses and \$36,526,187 in benefits paid to participants and beneficiaries.
